Supplementary Regulations

Ilkley & District Motor Club Limited will organise an Open Time and Observation Trial on Saturday 21st March 2026 for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting.

ELIGIBILITY Open to adult (aged at least 16 per TSR 1) registered members of ACU affiliated Clubs. All riders and passengers must hold a current ACU / SACU Trials Registration card or ACU/SACU competition licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance.

MACHINES Motorcycles as per NSC Appendix D Category 1, Group A1 Solos TSR 8.

CLASSES Main Event: Expert, Intermediate, Novice (and First Timer, Over 40, Over 50)
Clubmans Event: Clubman (any status) (and First Timer, Over 40, Over 50)

START VENUE Start at Middleton Moor, Ilkley (Map Ref 104/115505) Signposted from Ilkley bridge and accessed from road at 104/107505. **Use postcode LS29 0EG** to get close to the start. What3Words: november.quieter.contrived. All riders to be signed on by 12.30pm in accordance with TSR 2. First rider starts at 1.00pm followed by others at 30 second intervals. Individual start times will be notified via the ACU entries system. A controlled designated area will be available to store fuel cans for refuelling near the start area. **When refuelling an environmental mat must be used.** No refreshments but toilet facilities will be available at the venue.

ENTRIES Pre-entry only via the ACU online entry https://acu.sport80.com/v/872936/e/trial_events or acu.sport80.com/events. Entries will close on Wednesday 18th March 2026 at 21.00hrs. Entries are limited to 60. Only those who fulfil the eligibility criteria will be allowed to enter.
The entry fee is £27 for the full event, £22 for the Clubmans event. Entry fee includes a £2 environmental levy for the event*. Entries will be allocated on a first received, first served basis.
Team Entries (three main event riders only) £10.00 payable at the start. No rider may be in more than one team.
All money raised by the £2 levy will be used to offset the carbon footprint of the event and donated to Yorkshire Dales National Parks.

COURSE Main event; three laps of 20 sections (approximately 10 miles per lap).
Clubmans event; two laps of 20 sections (approximately 10 miles per lap).
All the observed sections are on private land. Course closing is by way of back-marker riders.

PLEASE NOTE: The majority of the event is within the West Nidderdale SSSI (Site of Special Scientific Interest) and the public have access to most roads. The following conditions are to preserve the continued running of the event. Any breaches of these conditions will result in EXCLUSION from the event.

- The route will be way-marked by flags at a maximum of 50 metres apart and must be followed closely.
- Footpaths must be crossed at designated points as instructed.
- All observed sections must be attempted in consecutive number order on each lap.
- Riders must stop at the start / finish gates on each lap and wait for the timekeeper's signal to re start.
- Riders must wait at section start for the observer's signal to start.

METHOD of MARKING Based on timing and observation.

OBSERVATION Per TSR 22B (Non-stop). Ties will be resolved per TSR 23. Failure to attempt a section: 10 marks

TIMING The average of the times of the ten fastest riders for each event will be taken as STANDARD TIME for that event. One mark lost for each minute or part of a minute slower than the standard time. Competitors more than 60 minutes later than standard time are deemed to have retired. All competitors must report to the timekeepers at the start/finish line of the trial.
